Students entering 9th grade must have the following:

Standardized test scores and previous academic coursework demonstrating readiness for Algebra I, English I, and high school entry level Science and History. Confirmation of promotion from grade 8 to grade 9.

Students entering grades other than ninth in high school must have the following:

Earned enough credits in previous high school grades to meet the qualifications for the grade for which they are applying.

Record of high school credits* to meet the graduation requirements for either college tech prep or college/university courses of study.

If enrolled in the college tech prep course of study, they must be able to meet requirements for the fine arts or business technology pathways.

Home schooled students must have the following:

Standardized test scores and previous academic coursework demonstrating readiness for Algebra I, English I, and high school entry level Science and History.

Earned enough credits* in previous high school grades to meet the qualifications for the grade for which they are applying.

DISCIPLINE STATUS
